#### **ABOUT THE THEME**

For too long, the Indian criminal justice system has worked more for the file than for the people, prioritizing procedural formalities over substantive justice. The theme for Volume 8 Issue 1 is "*Decoding India's New Criminal Codes.*" The enactment of the **Bharatiya Nyaya Sanhita (BNS)**, 2023, the **Bharatiya Nagarik Suraksha Sanhita (BNSS)**, 2023, and the **Bharatiya Sakshya Adhiniyam** (**BSA**), 2023 marks a watershed moment in India's legal history, replacing colonial-era statutes with a modernized criminal justice framework. While the codification of these laws represents a significant legislative overhaul, their true test lies in implementation, how effectively they translate from statute books into practice, exploring challenges such as institutional readiness, technological adaptation, and judicial interpretation. It invites scholarly discourse on whether these laws truly enhance access to justice, procedural efficiency, and victim rights, or if they risk perpetuating existing systemic gaps. By analyzing enforcement hurdles, comparative perspectives, and early judicial trends, this journal issue aims to provide a balanced academic assessment of India's transformative criminal laws.

#### SUBMISSION GUIDELINES

#### **Manuscript Guidelines:**

- Long and short articles must be accompanied by an abstract of not more than 250 words.
- There can be a maximum of one co- author in one submission.
- All manuscripts must be submitted in **English** language only.
- The research paper must be original and unpublished work of the author(s).Plagiarism above 10 % shall attract immediate disqualification.
- The manuscript must be typewritten. The font should be Times New Roman, font size 12, line spacing 1.5, justified alignment (except the title and 'abstract' caption which should be centrally aligned). All pages shall be numbered.
- All entries should be submitted electronically in .doc or .docx format.
- All manuscripts must be accompanied by:
  - A <u>cover letter</u> with the name(s) of author(s), designation, institution/affiliation, the title of the manuscript and contact information (correspondence address, email id, phone number etc.).
  - A declaration that the manuscript submitted is a piece of original and bonafide research work and has not been published or submitted for publication elsewhere.
- No biographical information or references, including the name(s) of the author(s), affiliation(s) and acknowledgements should be included in the text of the manuscript, the name or document properties.
- Authors are required to inform the Editorial Board if they have submitted their manuscript to another law journal and if they have received an acceptance for publication.

#### **Mode of Citation**

All citations shall be placed in foot-notes. ILI Rules of Footnoting must be adhered to. The footnotes must be typewritten in the font Times New Roman, font size 10, line spacing 1.0 and justified alignment.
